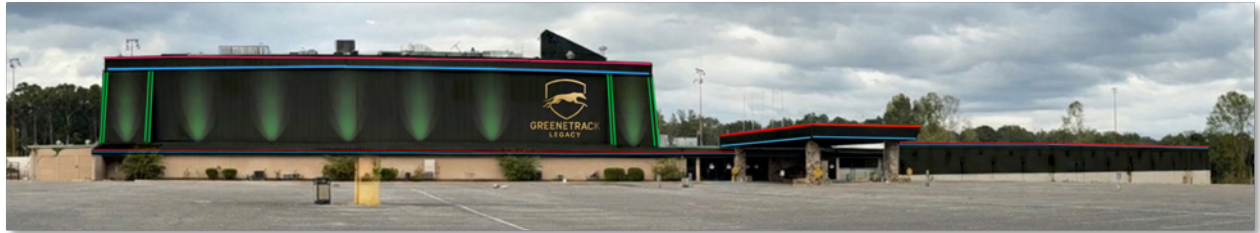

Greene County, Alabama — First Biometrics, together with Cybernetixs.AI, Iron Wolf Media LLC, and **Verde Bridge Properties LLC**, announced a transformative development partnership that plans to position **Greenetrack** as a long-term economic, technological, and community infrastructure destination for Greene County.

Following the Greene County Commission's approval of the lease framework on May 1, 2025, construction and facility stabilization efforts have already begun at the Greenetrack site.

This multi-agency, multi-investor partnership—with support from county commissioners, municipal leaders, and strategic private partners—introduces a new era of AI security, infrastructure modernization, gaming innovation, and regional development.
